THE FOLLOWING VERBAL AND/OR WRITTEN INSTRUCTIONS WERE COMMUNICATED TO THE CLIENT:

1. EVERY 30 MINUTES FOR 2 HOURS AFTER PROCEDURE, LIGHTLY DAB BROWS WITH DAMPENED GAUZE.
2. EVERY NIGHT STARTING ON THE DAY OF THE PROCEDURE, WASH BROWS WITH DIAL ANTIBACTERIAL SOAP OR UNSCENTED DOVE BAR SOAP. DO NOT RUB, GENTLY PAT BROWS WITH SOAP SUDS AND RINSE. MAKE SURE BROWS ARE COMPLETELY DRY BEFORE APPLYING A THIN LAYER OF THE AFTERCARE OINTMENT PROVIDED. REPEAT EVERY MORNING AND NIGHT FOR 1 WEEK.
3. DO NOT PICK YOUR SCABS, IT CAN REMOVE THE PIGMENT.
4. DO NOT WAX OR TINT YOUR BROWS FOR AT LEAST 3 WEEKS.
5. DO NOT GO SWIMMING, TANNING OR INTO SAUNAS FOR AT LEAST 14 DAYS.
6. DO NOT USE RETINOL, RETINA OR VITAMIN A DERIVATIVES ON OR AROUND THE TREATED AREA FOR AT LEAST 3 WEEKS.
7. CONTACT WITH ANIMALS INCLUDING ANIMAL DANDER AND GARDENING CAN CAUSE INFECTION SO DO SO AT YOUR OWN RISK.
8. SIGNS AND SYMPTOMS OF INFECTION INCLUDE, BUT ARE NOT LIMITED TO, REDNESS, SWELLING, TENDERNESS OF THE PROCEDURE SITE, RED STREAKS GOING FROM THE PROCEDURE SITE TOWARDS THE HEART, ELEVATED BODY TEMPERATURE, OR PURULENT DRAINAGE FROM THE PROCEDURE SITE.
9. A PHYSICIAN WILL NEED TO BE CONTACTED BY THE CLIENT IN THE CASE THAT ANY OF THE ADDRESSED SIGNS AND SYMPTOMS APPEAR, OR FOR ANY OTHER REASON RELATED TO THE BODY ART PROCEDURE(S).
