

INFORMED CONSENT TO COSMETIC TATTOO

PLEASE READ THE FOLLOWING AND BE CERTAIN YOU UNDERSTAND THE IMPLICATIONS OF SIGNING

IN CONSIDERATION OF RECEIVING PERMANENT COSMETICS FROM MORGAN LOPEZ, THE PRACTITIONER AT SILK & SAGE STUDIO, (TOGETHER WITH ITS EMPLOYEES/APPRENTICES, AND AGENTS, THE "BODY ART BUSINESS") I, _____, CONFIRM THE FOLLOWING BY INITIALING EACH APPLICABLE ITEM:

- ___ ALL QUESTIONS ABOUT THE BODY ART WORK HAVE BEEN ANSWERED TO MY SATISFACTION, AND I HAVE BEEN GIVEN WRITTEN AND VERBAL AFTERCARE INSTRUCTIONS FOR THE COSMETIC TATTOO I AM ABOUT TO RECEIVE.
- ___ THE BODY ART HAS BEEN THOROUGHLY DESCRIBED TO ME.
- ___ I UNDERSTAND THAT TATTOOING IS PERMANENT AND THAT IF I CHOOSE TO HAVE IT REMOVED, IT MAY BE EXPENSIVE AND LEAVE SCARS.
- ___ I AM THE PERSON ON THE LEGAL ID PRESENTED AS PROOF THAT I AM AT LEAST 18 YEARS OF AGE.
- ___ I AM NOT UNDER THE INFLUENCE OF ALCOHOL OR DRUGS AND THAT I AM VOLUNTARILY SUBMITTING TO BODY ART WORK WITHOUT DURESS OR COERCION.

WHAT TO EXPECT AFTER TREATMENT:

THE ENTIRE HEALING PROCESS WILL TAKE FROM 4-6 WEEKS DEPENDING ON YOUR AGE AND HOW FREQUENTLY YOUR BODY REGENERATES ITS SKIN CELLS.

YOUR NEW EYEBROWS WILL GO THROUGH SEVERAL PHASES DURING THE HEALING CYCLE. THE PIGMENT WILL APPEAR VERY NATURAL LOOKING IMMEDIATELY AFTER THE PROCEDURE. OVER THE NEXT SEVERAL DAYS, THE COLOR OF THE PIGMENT WILL APPEAR MUCH DARKER. BECAUSE OF OUR NATURAL SKIN CELL TURNOVER, AFTER RECOVERY PERIOD (PEELING), BROWS MIGHT APPEAR LIGHTER THAN ORIGINALLY. THIS OFTEN GIVES THE IMPRESSION THAT THE COLOR IS FADING TOO QUICKLY. EVEN WITH PROPER CARE, CLIENTS MAY LOSE ORIGINAL HAIR STROKES WHICH MAKE BROWS LOOK UNEVEN. IT IS ABSOLUTELY NORMAL. THIS IS THE REASON WE BOOK A TOUCHUP FOR AT LEAST 8 WEEKS AFTER YOUR INITIAL APPOINTMENT.

ONCE THE HEALING OF THE SKIN STARTS TAKING PLACE, IT WILL LOOK LIKE DANDRUFF FLAKES OR DRY SKIN, HOWEVER, THIS IS JUST SUPERFICIAL COLOR AND DEAD SKIN BEING NATURALLY REMOVED FROM YOUR EYEBROWS. THE FINAL LOOK OF YOUR EYEBROWS WILL BE APPARENT APPROXIMATELY 30 DAYS AFTER YOUR PROCEDURE. TRY TO AVOID RUBBING THE TREATED AREA, AS IT CAN INTERFERE WITH YOUR SKIN'S NATURAL HEALING PROCESS.

ONCE COMPLETELY HEALED, ALWAYS APPLY A SPF RANGING FROM 30 TO 50 ON YOUR EYEBROWS WHEN EXPOSED TO THE SUN. FREQUENT SUN EXPOSURE, USE OF RETINOIDS, PEELS, LASER TREATMENTS AND OTHER POWERFUL EXFOLIATORS WILL CAUSE THE PIGMENT TO FADE AWAY MORE QUICKLY. TO MAINTAIN CRISP AND CONCENTRATED PIGMENT, IT IS RECOMMENDED TO GET A TOUCH UP EVERY 12-18 MONTHS AFTER YOUR INITIAL APPOINTMENT.

___ I UNDERSTAND THERE IS A POSSIBILITY OF AN ALLERGIC REACTION.

___ I UNDERSTAND THERE IS A POSSIBILITY OF GETTING AN INFECTION.

___ I UNDERSTAND THAT THERE IS A CHANCE I MIGHT FEEL LIGHTEADED OR DIZZY DURING OR AFTER COSMETIC TREATMENT.

___ I UNDERSTAND THAT ALL TATTOO INKS, DYES, AND PIGMENTS HAVE NOT BEEN APPROVED BY THE FEDERAL FOOD AND DRUG ADMINISTRATION AND THAT THE HEALTH CONSEQUENCES OF USING THESE PRODUCTS IS UNKNOWN.

___ I AGREE TO FOLLOW ALL INSTRUCTIONS CONCERNING THE CARE OF MY COSMETIC TATTOO, AND THAT ANY TOUCH-UPS OR REPAIRS THAT MAY BECOME NEEDED DUE TO MY OWN NEGLIGENCE WILL BE DONE AT MY OWN EXPENSE.

___ I AGREE TO IMMEDIATELY NOTIFY THE ARTIST IN THE EVENT I FEEL LIGHTEADED, DIZZY AND/OR FAINT BEFORE, DURING OR AFTER THE PROCEDURE.

I, _____, HAVE BEEN FULLY INFORMED OF THE RISKS OF BODY ART INCLUDING, BUT NOT LIMITED TO INFECTION, SCARRING, DIFFICULTIES IN DETECTING MELANOMA, AND ALLERGIC REACTIONS TO PIGMENTS, LATEX GLOVES, AND ANTIBIOTICS. HAVING BEEN INFORMED OF THE POTENTIAL RISKS ASSOCIATED WITH OBTAINING SAID COSMETIC TATTOO, I STILL WISH TO PROCEED WITH THE COSMETIC TATTOO AND I ASSUME ANY AND ALL RISKS THAT MAY ARISE FROM THE COSMETIC TATTOO.
